#### *Coming from Seattle (Heading East on I-90)*

- \* On I-90 take Exit 10A to merge onto I-405 N toward Bothell/Everett
- \* Take exit 23 toward Woodinville/Wenatchee/Seattle/Bothell/US-2
- \* Merge onto WA-522 E
- \* Take the WA-202 E exit toward Woodinville/Redmond
- \* Turn right onto WA-202 E/131<sup>st</sup> Ave NE and continue to follow 131<sup>st</sup> Ave NE
- \* Continue onto NE 173<sup>rd</sup> St
- \* Sharp right onto NE 172<sup>nd</sup> St
- \* Continue onto 148<sup>th</sup> Ave NE (Center on Left)

#### *Coming from Spokane (Heading West on I-90)*

- \* On I-90 take Exit 10 to merge onto I-405 N toward Bellevue
- \* Take exit 23 toward Woodinville/Wenatchee/Seattle/Bothell/US-2
- \* Merge onto WA-522 E
- \* Take the WA-202 E exit toward Woodinville/Redmond
- \* Turn right onto WA-202 E/131<sup>st</sup> Ave NE and continue to follow 131<sup>st</sup> Ave NE
- \* Continue onto NE 173<sup>rd</sup> St
- \* Sharp right onto NE 172<sup>nd</sup> St
- \* Continue onto 148<sup>th</sup> Ave NE (Center on Left)
